# **❖** AGE CRITERIA

Minimum 18 years and maximum 24 years as on date of advertisement.

## **❖** STIPEND

The apprentices are eligible for monthly stipend as per Apprentices Act, 1961, Apprenticeship Rules 1992 as amended from to time during their engagement period.

**RESERVATION:** As per the guidelines of Govt. of Odisha, shall be followed with applicable age relaxation.

#### **SELECTION**

Selection for engagement of Apprentices for training would be on merit basis, considering their percentage of marks obtained in the basic prescribed qualifications as applicable to respective branch/trade.

#### **❖** GENERAL INSTRUCTION:

- ❖ Candidates are advised to carefully read the full advertisement for details of eligibility criteria and selection modalities.
- ❖ Vacancies displayed above are indicative and may change any time during the period of engagement based on our requirement.

- ❖ Only those candidates are eligible who have not undergone apprenticeship training in the past as per the Apprenticeship Act 1961/1973.
- ❖ Sundargarh District residents will be given preference over others. Applications from other districts of Odisha may be considered, only if there are any vacancies left after the selection process which cannot be filled by Sundargarh District residents
- \* Rourkela Steel Plant will not provide any sort of accommodation during the training. Apprentices shall have to make their own arrangement.
- \* Rourkela Steel Plant is not liable for providing any sort of Travel Allowance to the applicants.
- ❖ Engagement for training of selected candidates is subject to his/her being declared medically fit as per the requirement of the Apprentices Act, 1961. Medical certificate issued by Govt doctor. Seal on the certificate should contain medical registration number of the doctor.
- ❖ Management reserves the sole right to cancel the advertisement and /or the selection process there under. Decision of Management regarding the selection will be final. Further Management reserves the full right to fill up or otherwise any or all the notified posts depending on the availability of the candidates in any trade/discipline and also to fill up the vacancies if any. The vacancies in each trade are indicative and may be vary during selection process.
- \* RSP shall have no obligation to offer regular employment to Apprentices during and/or after the completion of the apprenticeship training. After successful completion of Apprenticeship, candidates shall be relieved from the establishment.

  - II. Canvassing of any kind shall disqualify the candidate.

#### **❖** REQUIREMENT BEFORE FILLING ON-LINE REGISTRATION

- I. Before applying for above apprentices positions, candidates have to first register themselves in online portals of the following agencies of Govt. of India:

  - (b) For Graduate/Technician Apprentices: National Apprenticeship Training Scheme (NATS) in the link <a href="https://portal.mhrdnats.gov.in">https://portal.mhrdnats.gov.in</a>(Discipline mentioned in Sl. No 23 to 39)
- II. The candidate must have an active email ID and Mobile Number which must be valid for at least next one year. All future communication including Corrigendum/Addendum with regard to this advertisement with candidate will take place only through e-mail / SMS Alerts.
- III. The candidate must ascertain the correctness of all information before filling in the online registration and its final submission.
- IV. The candidate shall be wholly/exclusively responsible for the information provided in his/her online registration.
- V. After successfully registration/apply online, the candidate must take a print out of the filled-in online application for future reference.

#### HOW TO APPLY

- A) **For ITI**: Candidates are first required to register in the web portal **http://apprenticeshipindia.org** for registration as candidate. After registering oneself, one can login into the home page in the apprenticeship portal as candidate then go to Apprenticeship Opportunity than click search by **Establishments Name (SAIL ROURKELA STEEL PLANT)** to click on apply as the prescribed trade against vacancies appearing on the portal. The candidates have to apply for the respective trade through Apprenticeship Opportunity of the establishment SAIL Rourkela Steel Plant. The application will not be accepted without registration and apply on the portal.
- B) For Degree/Diploma: Candidates are advised to register as a student online on https://portal.mhrdnats.gov.in. After registering oneself, one can login into the home page of NATS portal as candidate then go to Establishments Requests than click Find Establishments. Candidate should select SAIL Rourkela Steel Plant (EORSUS000001) to apply in passed out branch of engineering against vacancies appearing on the portal.

#### **❖ JOINING AND VERIFICATION OF DOCUMENTS**

- i. The candidature of applicant would be provisional and subject to subsequent verification of certificates and testimonials. In case, it is detected at any stage of training or thereafter, that a candidate does not fulfill the eligibility norms and or/that he has furnished any incorrect/false information/certificate/documents or has suppressed any material fact, his/her candidature will stand cancelled.
- ii. The following documents failing which your case for Apprenticeship training shall not considered under any circumstances.
  - 1) Original Institution Leaving Certificate (to be retained by the RSP till completion of training).
  - 2) Attested copy of Provisional Diploma Pass Certificate
  - 3) Attested copy of SC/ST/OBC/PH Certificate
  - 4) Medical Fitness Certificate from the Govt. Hospital.
- iii. The verification of the original documents shall be done prior to joining on a specific date. A print out of registration form may be taken from the website and brought during document verification.
- iv. The date of Joining and Venue of the selected candidates will be intimated through e-mail/SMS alert.
